Nominations Committee Announces Recommendations for MCCF Officers 2025-2026

The MCCF Nominations Committee has recommended the following slate of officers for the 2025-2026 term:

- █ President: Cheryl Gannon
- █ First Vice President: Joyce Gwadz
- █ Second Vice President: Elizabeth Joyce
- █ Secretary: Alan Bowser
- █ Treasurer: Jerry Garson

The slate will be formally announced at the MCCF May meeting, where nominations by a Delegate from a member organization may also be accepted from the floor. Nominations from the floor require a second by Delegates from three member organizations (different from that of the nominating Delegate). Elections will be held by

secret ballot during May and June and announced at the June meeting. A majority of ballots is required for each officer.

The Nominations Committee included Chair Elizabeth Joyce,

Brenda Freeman, Jay Elvove, Ken Markison, and Daniel Meijer. The Committee is grateful for the candidates' willingness to serve the Federation for the 2025-2026 term. █

The Rules on Officer Nominations by Nominating Committee or by Delegate, Officer Elections

The amended Bylaws, adopted by the Delegates at the April 2025 general meeting, provide two methods for the nomination of our five MCCF Officers. The first method is the nomination of a full slate of candidates recommended by the Nominations Committee. The second is the nomination of a candidate or candidates by a Delegate "from the floor" at the May meeting. A

Delegate-initiated nomination must be seconded by Delegates from three member associations different from the moving Delegate's association. [Art. VI, Sec. 2.]

By either path to nomination, each Officer is elected by electronic secret ballot during May and June. The Bylaws require a majority of ballots cast to elect an Officer. If no

candidate receives a majority initially, a "runoff" between the two top contenders is held, also by electronic secret ballot.

All Delegates receive a ballot, which must be returned by a stated due date. [Art. VI, Sec. 4.] The winning candidates are announced at the June annual meeting and awards ceremony, and they take office immediately thereafter. [Art. VI, Sec. 3.]

General Meeting Minutes, April 14, 2025, 7 p.m., via Zoom

- 1. Call to Order.** The meeting was called to order at 7 p.m.
- 2. Adoption of Agenda.** The agenda was approved
- 3. Adoption of Minutes.** The minutes of the March 10, 2025 meeting were approved.
- 4. Treasurer's Report.** The Treasurer Jerry Garson reported a bank balance of \$6,963.00.
- 5. April Program**

Angie McCarthy, Maryland Conservation Advocate at Nature Forward, presented information on proliferation of data centers throughout the region, and especially in Loudoun

and Prince William counties in Virginia. She discussed the energy and other requirements for data centers and the impact on the environment, notably the significant need for water for cooling and the light and sound impacts. She said that, because of the high energy usage of the centers, there was increasing pressure on energy prices in local communities, leading to higher energy bills for residents. Renewable energy sources could not cover the massive energy needs of the centers, leading to increased demand for nonrenewable fossil fuel sources for power, namely, coal, natural gas and nuclear power.

It was noted that, in Maryland, 40% of its energy needs were imported from fossil fuel sources, an amount that would increase due to

the establishment of new data centers, the increase in EV charging stations, and other new electricity uses.

McCarthy said that local communities needed to become more aware of government policies to site data center facilities in their Counties and State. Delegates and members commented on the presentation and asked questions about the impact of data centers on water usage from the Potomac and other issues.

6. Resolution to Amend the Bylaws of the Montgomery County Civic Federation. President Cheryl Gannon reviewed the process for updating the MCCF bylaws, thanking the members of the bylaws committee—chaired by Joe Harkins and including 1st Vice President Joyce Gwadz, Somerset

Mayor Jeffery Slavin, and MCCF Secretary Alan Bowser—for their efforts. She noted that no amendments had been received from Delegates, after the March meeting where the proposed bylaws amendments had been presented, for consideration by the Committee.

Bylaws Committee Chair Joe Harkins presented the several new amendments to the Federation bylaws that had been drafted by the Bylaws Committee, taking into account suggestions from Delegates at the March 2025 Federation Meeting. The Committee Chairman subsequently made a motion to approve the amended bylaws which was properly seconded by Delegates. A proposal to table the discussion of the bylaws changes was ruled out of order, with the President noting that current Federation bylaws required a vote on the bylaws changes at the

meeting where the amendments were presented.

Delegates both opposed to and supportive of the proposed bylaws changes commented on the amendments. Delegates opposed to the proposed bylaws focused on proposed Committee structure, the continued use of virtual meetings, and the role and privileges of past MCCF Presidents. Delegates supportive of the proposed changes commended the emphasis on a Delegate-focused structure, the adoption of best governance practices, and the value of virtual meetings.

The President and the Committee Chair advised that Delegates could always present amendments to the Federation bylaws for consideration at a future meeting. After discussion, the motion to approve the Resolution to amend the bylaws was passed by a

vote of 44 in favor, 6 opposed, and 3 abstentions. The Resolution follows.

RESOLUTION TO ADOPT AMENDMENTS TO FEDERATION BYLAWS IN ACCORDANCE WITH REDLINE DEVELOPED BY SPECIAL BYLAWS COMMITTEE, 2025

Whereas, a special Bylaws Committee was appointed by the President and approved by the Delegates in Fall 2024; and

Whereas, the Federation's Bylaws have not received a comprehensive review and revision since 2013; and

Whereas, the Bylaws Committee reviewed and analyzed the 2013 By-

laws with the aim of updating them and aligning them with best practices for similar nonprofit organizations; and

Whereas, MCCF's organizational structure can be streamlined to facilitate its efficiency; and

Whereas, the Board of Directors and Executive Committee can be reconstituted to better define their respective strategic and tactical roles; and

Whereas, the number of Standing Committees and Appointed Officials can be reduced to reflect current volunteer staffing; and

Whereas, the various categories of membership in the Federation can be refined to increase the commitment and scope of members, par-

ticularly those of Local Associations; and

Whereas, the overall effectiveness of MCCF as an advocacy organization can be enhanced by centering the representational and voting roles of Delegates;

Therefore, be it resolved that the amendments to the Bylaws developed by the Bylaws Committee and recommended for approval by the Executive Committee, as posted on the website in redlined and clean versions during March, and now also posted in April, as just described, be adopted at the April 14, 2025, General Federation meeting, to take effect immediately thereafter.

7. Adjournment. The meeting was adjourned at 9:02 p.m. ■

4. 2025 Civic Federation Awards.

After discussion and motion, the Committee, acting as the Awards Committee, nominated the following individuals and organizations for award: Luxmanor Civic Association—The Sentinel Award; Friends of Sligo Creek—The Wayne Goldstein Award; and Joseph Harkins—The Star Cup.

5. May General Meeting. Montgomery County Councilmember-at-Large Evan Glass will be invited to discuss Montgomery County housing and other issues.
